In the case of discrepancies or error in bid documents, bid notice or any other documents, Harion Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any

discrepancy may occur then the figure written in word is valid.

Bids shall be opened in the presence of Bidders' representatives, who choose to attendat 2:00 PM on 31th day of Notice Published in Harion Municipality. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at (Dharauti account No. 13203000000003000001) on behalf of of Harion Municipality, Harion, Sarlahi at Nepal Bank Limited, Harion Branch, Sarlahi, or bid security authorized from a recognized commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity period.

If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized

with effect from the original bid submission deadline.
